**Privacy Policy**

**Effective Day.** This Privacy Policy (this Policy) is effective on September 23, 2024.

**I. Personal Information and Account**

Personal Information means personally identifiable information such as name, sex, nationality, social security number, driver license, date of birth, family members, personal habits, house address, mailing address, bank information, car plate, post code, email addresses, telephone, fax or mobile numbers, account number, education background, work experience, employer, economic status, disease suffered and history, therapy used, copyright, grants received or donation record, e-commerce record, which are provided via forms, surveys, applications or other online ways.
